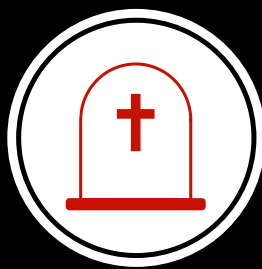

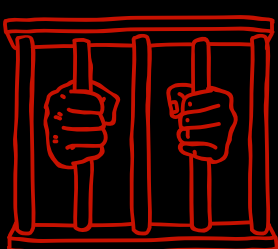
METH IS A SCHEDULE II SUBSTANCE AND IS CLASSIFIED AS A DANGEROUS DRUG.

CONVICTION

METHAMPHETAMINE RELATED OFFENCES HAS A MANDATORY SIX MONTH PRISON SENTENCE.

CLASS A FELONY

POSSESSION OR DISTRIBUTION OF A DANGEROUS DRUG IN ANY AMOUNT TO A MINOR IS A FIRST DEGREE OFFENSE AND FALLS UNDER A CLASS A FELONY.
