## What is your advocacy style?

### Let's get ready to advocate!

- Substituting your beliefs as the advocate for the beliefs of others
- Creating conflict for conflict sake
- A chance to get even for past wrongs done to you
- An opportunity to make yourself feel powerful at the expense of others

## **Advocacy is Not!**

The reputation of advocacy, and advocates will suffer or improve depending on our advocacy approach.

#### • Remember:

- Be assertive, not adversarial
- Research, be prepared and knowledgeable
- Believe in the cause, and for whom you are advocating
